- All tables will come with 2 chairs, 1 tablecloth, & 2 Vendor Passes, additional passes can be purchased the day of the show.
- Electricity is available but must be arranged with the promoter prior to date of the show.
- Holiday Inn does offer complimentary WiFi, and there is an ATM available near the front desk of the Hotel.
- Table Floor plan must stay as designed unless previously arranged with the Show Promoter.
- Vendors are requested to stay set up until the end of the show at 4:00pm
- Jason (Show Promoter) will be going around at 2pm to reserve tables for the next expo at which time vendors will be allowed to retain their existing table location for the same price that was paid for the current expo.
